If there is one thing we have grasped over the eleven years of the Festival, it is that when we talk about economics we are not just dealing with numbers or the financial markets, but rather with something that concerns all of our lives. This is a concept we believe is even clearer in this year's edition, the twelfth, focusing on the subject of "Unequal Health". One of the great merits of Trento Festival of Economics has always been this concrete approach to choosing its subject matter, highlighting the crucial questions of our time and the social and economic problems that influence people's lives, while at the same time trying to identify possible solutions.

The word inequality brings to mind an appeal made by Pope Francis, namely to start from the outskirts. There are many peripheral areas that we must concern ourselves with. Dealing with equality in terms of access to health means facing problems of this kind, both in a small area such as our own, and in a more global context. We must reflect on how to ensure everyone has the same chances in terms of health, how much this has to do with the socioeconomic, environmental and cultural development of the area and how citizens can be the key figures in the fight against inequality. It is therefore an inclusive subject, with which we also launch a message about the model of development we wish to adopt in our society.

We know that health is not distributed homogeneously among individuals in the population. There are some unchangeable elements that lead to these differences, such as genetic factors, age, gender or other individual characteristics. There are however also modifiable factors that are the fruit of cultural, economic and political processes, as regards which we can instead take action. Education, for example, together with economic conditions and employment, is one of the fundamental social "determinants" in health. In Italy, people with a higher level of education, those with a diploma or degree, have a significantly longer life expectancy, around 6 or 7 years extra compared to those with a lower educational level. This gap has increased over time and can be observed in all age groups. Guaranteeing access to higher levels of education and improving socioeconomic conditions, also through better employment stability, thus represents a good starting point for reducing health inequality and increasing collective wellbeing in the wider sense.

I believe that the question of fairness as regards access to health represents an ethical imperative for society overall and must therefore be an objective of all policy, not just social and health policy. In Trentino we invest around a third of our budget in the health of our citizens. We do so with conviction, because we believe that it is fundamental to improve the wellbeing of the population, extending healthy ageing and reducing avoidable and premature mortality, with the objective of placing the individual at the centre of a fair, effective, safe and sustainable health and welfare system. The mistake often made is to consider health purely as a cost and hence as an obstacle to development. In actual fact, if dealt with correctly, the need to promote health can also represent a factor in competitiveness. Investing in health means investing in the human capital of society, the true driving force for economic growth.

The 2017 Festival will thus be an extraordinary opportunity to consider a subject that once again matches perfectly with the goal of the event, namely to act as a place where can Trentino reflect on economic matters in the context of global dynamics.

In this period health is more than ever at the centre of public debate. Deeds and misdeeds, opinions and misinformation regarding vaccines, medical errors, health cuts, the new frontiers in health and correct lifestyles for remaining healthy are bounced around on a daily basis by the media and the virtual marketplace represented by social networks. This is without considering the fact that each of us experiences the positive and negative aspects of our national health service, which it should be recalled is a relatively recent conquest, directly or through family members and acquaintances. It was 1980 when Italy abandoned the old mutual benefit schemes, which linked the right to health protection not to citizenship but rather to employment (or that of a family member). Over thirty years later, article 32 of the Constitution, which considers health as a "fundamental right of the individual and in the interests of the community" was thus implemented.

However, today this major achievement is not infrequently called into question. For various reasons: because being entitled to care does not necessarily mean being entitled to the best care, as demonstrated by the events recounted by those who have the misfortune to suffer from cancer or contract hepatitis C; because it is not necessarily true that those living in Sicily have the same level of care guaranteed in Lombardia or Trentino; because what happens in Europe in terms of universal health cover is often disconcerting: I refer for example to the Immigration Act passed a while ago across the English Channel, which obliges immigrants from outside the European Union who work or study in the United Kingdom on a non-permanent basis to pay an annual tax in order to have access to the health service.

Thus this twelfth edition of the Festival of Economics has once again hit the bull's eye by choosing a subject that not only has extremely important political and economic implications, but also a crucial impact on people's lives. On the other hand, individuals play an active role in determining their own health: it has indeed been demonstrated that life expectancy is dependant in a decisive manner on lifestyle and level of education, not just on income and the health system in the place of residence. The right to health is thus a question of social justice, which means that eliminating inequality, increasing people's responsibility and making them more educated and aware is already the first step towards making them healthier and ensuring they live longer.

If this is the case, if basing our society on fairer foundations also means improving the general health of the population, then health and social issues cannot be separated. As ever, we expect the Festival to give us suggestions helping to clarify our ideas and take the right path, creating policy that is able to guarantee the quality of care, efficiency and thus intelligent use of the resources available, with an awareness that health is often a choice and not something that is fated to happen.

When we talk about Economics we tend to think of documents full of numbers, percentages and graphs: an abyss of boredom and aridity (this is also the reason why Thomas Carlyle described economics as the “dismal science”). However, this is an unwarranted prejudice. In truth economics, as is evident in its etymological meaning (“management of a household”), has to do with our everyday lives, namely with the material and spiritual dimension of our existence, and thus also with our health.

There is a two-way relationship between the state of the economy and the health of citizens: if the former improves, the latter will also tend to do so, and vice-versa. The 2017 Festival of Economics allows us to reflect on this fundamental issue and the many possible ramifications, because it is clear that in addition to economics, safeguarding health also involves scientific research and the welfare system, which should guarantee equal conditions and opportunities for all citizens.

There is indeed a very close link between health, environmental and socioeconomic factors, and the coverage and quality of health services. On the one hand, the major differences still evident in individuals’ health, both between different countries and within the same nation, reflect profound inequality in terms of environmental factors, as well as the income and lifestyles of individuals. On the other, different levels of health affect citizens positively or negatively from the moment of birth. By taking action in relation to environmental factors and through targeted redistribution of resources and health and welfare services, public institutions can contribute towards reducing the differences between individuals and orienting them towards sensible lifestyle choices.

Scientific and technological progress makes the picture even more complex. For example, the discovery of microbial mechanisms for the transmission of diseases has contributed in a decisive way to the wellbeing of the population. Increased knowledge has made new tools and solutions for prevention, screening and the care of diseases available, but requires significant investment in the research and development phase, and often involves an increase in the cost of health services: costs that end up by excluding less wealthy citizens. On the other hand, the ageing of the population, while reflecting a marked improvement in environmental conditions and income, has a major effect on the sustainability of universal healthcare systems.

In addition to financial aspects, health inequality concerns matters of a philosophical and legal nature, such as conscientious objection, the bioethics of end-of-life management and the safeguarding of vulnerable categories such as migrants. Similarly, reflection on health issues cannot fail to touch upon questions relating to sport, diet and correct nutrition education, which influence both individual lifestyles (one need only consider smoking and active ageing) and the environmental context. This year the Festival thus gives us once again the chance to reflect on issues of great importance for our lives and the future prospects of our country: this happens every year, but I believe that this edition touches on delicate and thought-provoking matters that are of particular interest to all aware and informed citizens.

## UNEQUAL HEALTH

I have always been fascinated by the work of the doctor; perhaps because it was my father's profession, or perhaps because doctors achieve tangible results, having the chance not only to treat and alleviate pain for many people, but also to save human lives. Even when economists provide the right "prescriptions," and it is by no means certain that this will take place, it is difficult to attribute the saving of human lives to their actions. There are some important exceptions, with economists who have achieved this result by contributing towards improving the organisation of healthcare or facilitating the matching up of supply and demand for organs. These exceptions will be amply represented in this edition of the festival, starting from the inaugural lecture.

Differences in people's health and life expectancy are sometimes more marked than differences in income levels. In terms of purchasing power, the average income in Gabon is just over a third of the figure in the United States, but the mortality rate in Gabon for children under the age of one is 5 out of every 100 live births, while in the United States this figure goes down to 5 out every 1000. Life expectancy can vary considerably even within the United States: those born and residing in rural areas, the areas voting Donald Trump into office, live on average up to 30 years less than those living in large cities. Gender imbalances are also becoming increasingly pronounced: women live longer than men, yet they are more likely to suffer from diseases causing pain and invalidity.

In developed countries, health inequality may experience a marked increase as a result of an ageing population, considering that recent estimates predict an increase of around 80% in spending on care for dependent elderly people who suffer from incipient dementia or Alzheimer's disease. Health cover and the quality of available services represent an important, albeit limited part of these differences: introducing free and universal healthcare is not enough to redress the imbalance in life expectancy. Access to universal healthcare was established in the UK immediately after the Second World War, yet in the 40 years that followed the introduction of free medical care for all citizens there was an increase in the health gap for British families. Cultural, environmental, social and work-related factors have a profound impact on quality of life, nutrition and disease prevention, while the cost of targeted treatment for some diseases is often too steep for even the most generous national healthcare systems.

When we talk about social mobility, the subject of debate in previous editions of the Festival, we tend to focus on people's position on the income ladder and forget that the most important aspect of equal opportunities is the chance to live a healthy life and enjoy an active old age. Public action in this field would be particularly advantageous, as creating environmental conditions more conducive to healthy life can have major positive spin-offs. However, these benefits are not always pursued in the public sector, which tends to focus on the effects rather than the causes of many common diseases. Too little attention is often paid to the ways in which the results of bio-medical research can improve the quality of life for millions of people. Healthcare systems rarely take into account issues linked to moral hazard, namely the possibility of health insurance having a detrimental effect, by reducing the incentives for people to follow a healthy lifestyle, thus minimising the risk of frequent recourse to medical care. Moreover, public debate often does not deal adequately with the problem of selectivity within universalism, namely with the fact that even in a health service extending health insurance to all citizens, the provision of costly services can require a significant contribution on the part of those with a higher income. The differing health levels observable can sometimes be traced back to individuals' varying degree of "health education". Increased awareness of health risks and healthcare alternatives could encourage healthy living without additional costs and avoid the incidence of

silent or discouraged patients who do not take full advantage of the healthcare and services available to them, because they are poorly informed about their rights and the range of services on offer. These are all examples of extremely relevant questions that economists can help to answer. As in previous editions, they will benefit from exchanges with experts in other fields, this time with an increased focus on so-called 'hard' science, to which after all we owe the extraordinary advances taking place in medicine in the last 50 years.

### TITO BOERI

President of INPS since February 2015, he is on leave from his posts as Professor of Economics at Bocconi University, where he had the role of Prorector for Research, and Centennial Professor at the London School of Economics. He has been the Scientific Director of the Fondazione Rodolfo De Benedetti ([www.frdb.org](http://www.frdb.org)) since it was established. He has published 13 books with Oxford University Press, MIT Press and Princeton University Press, along with numerous scientific articles in the most prestigious economics magazines. He was senior economist at the OECD, where he dealt with the transition of former Soviet Bloc countries to a market economy, and has been a consultant to the European Commission, the European Central Bank, the ILO, the World Bank and the Italian Government. He is a leader writer for "la Repubblica", a newspaper he has not written for since he was made President of INPS. He was the inspiration behind the economics website [www.lavoce.info](http://www.lavoce.info). He is a member of the Academia Europaea and a Research Fellow of the European Economic Association, CEPR, Center for Economic Performance, IZA, Netspar and Igier-Bocconi.

His most recent publications in Italian include: *Populismo e stato sociale*, Laterza (2017); *Parlerò solo di calcio*, Il Mulino (2012); *Le riforme a costo zero* (with Pietro Garibaldi), Chiarelettere (2011); *Classe dirigente* (editor, together with Antonio Merlo and Andrea Prat), Università Bocconi (2010); *La crisi non è uguale per tutti*, Rizzoli (2009); *Contro i giovani* (with Vincenzo Galasso), Mondadori (2007).

### MASSIMO ANTICHI

He was a member of the technical secretariat of the Ministry of the Treasury's *Technical Committee on Public Expenditure*. He was a member of the working group assigned the task of preparing lines of action on the pension system (the "Dini" law) by the Ministry of Employment, the *Committee for Analysis of the Macroeconomic Compatibility of Welfare Expenditure*, the *Social Security Spending Evaluation Team* and numerous ministerial committees studying pensions and social security matters. He was Director of the Economic Studies and Research Directorate of the Supervisory Commission on Pension Funds (COVIP). Until 2012 he was Director General of ENPALS, which then merged with INPS.

He was in charge of the temporary three-year general managerial project entitled *Coordination and integration of former ENPALS management activities with those of INPS*.

He was in charge of the temporary one-year general managerial project entitled *Coordination and integration of user satisfaction analysis and monitoring* aimed at reducing reputational risk. Since 1 February 2017 he has been Centre Director of the Central Study and Research Directorate at INPS.

### ORLEY ASHENFELTER

He is Joseph Douglas Green 1895 Professor of Economics and former Director of the Industrial Relations Section at Princeton University. He has been President of the American Economic Association, the American Law and Economics Association, and the Society of Labor Economics. He is currently President of the American Association of Wine Economists.

He edited the "American Economic Review" and founded and edited the "American Law and Economics Review."

As Director of the Office of Evaluation of the US Department of Labor in 1972, he began the work that is now widely recognized as the separate field of "quantitative social program evaluation." He is also regarded as the originator of the use of so-called "natural experiments" to infer causality about economic relationships. He has also been the leader in the recent emphasis in quantitative economic analysis on the use of creative methods of data collection.

He has been editor of the "American Economic Review" and founder and editor of the "American Law and Economics Review". Among other things, he has published *Discrimination in Labor Markets* (with A. Rees), Princeton University Press (2015), and *Statistics and Econometrics: Methods and Applications* (with P.B. Levine and D.J. Zimmerman), Wiley (2002).

### VINCENZO ATELLA

He is a Professor of Economics at the University of Rome "Tor Vergata". He is also adjunct associate of the CHP/PCOR (Center for health Policy) at Stanford where he has been visiting professor in different occasions.

Currently, he is CEIS Tor Vergata Director and Scientific Director of the Farmafactoring Foundation, chief economist of SIMG (Italian Association of General Practitioners) and member of the European Steering Group on Sustainable Health.

### **GIOVANNELLA BAGGIO**

Founder of the first national research centre on gender health and medicine, she is Ordinary Professor at the University of Padua, holding the Chair in Gender Medicine at the Department of Molecular Medicine, and Director of the General Medicine Unit at Padua Hospital. She is an elected member of the Management Committee of the International Society of Gender Medicine. Within the UOC (complex operations unit) she runs the Regional Centre on Gender Medicine. She was Associate Professor of Geriatrics and Gerontology at the Universities of Pavia and Padua from 1987 to 1995 and then Ordinary Professor at Sassari from 1995 to 1999. She is the author of over 270 papers in national and international magazines, in addition to 5 books; she is a referee and member of the editorial board for many international magazines.

### **FRANCESCO C. BILLARI**

He is a Prorector at Bocconi University, Professor of Demography at the Department of Policy Analysis and Public Management and President of the Dondena Centre. He is a Professorial Fellow of Nuffield College, Oxford, Honorary President of the European Association for Population Studies and a Fellow of the British Academy, and was among the founders of Population Europe. He manages a research project on the role of major social discontinuity (economic and technological) in family and demographic change, funded by the European Research Council.

He is the editor of Population Studies and Deputy Editor of "Demography". He edited *Teniamo famiglia*, Università Bocconi (2012), and published *La rivoluzione nella culla* (with G. Dalla Zuanna), Università Bocconi (2008).

### **OLIVIER BLANCHARD**

He is the Fred Bergsten Senior Fellow at the Peterson Institute of International Economics, and Robert Solow Professor of Economics Emeritus at MIT. He spent most of his career at MIT, but moved to Washington in 2008 to be the IMF's Chief Economist (Economic Counsellor and Director, Research Department), a post he retired from in 2015. His research interests are in macroeconomics, including a wide set of issues that range from the role of monetary policy to the nature of speculative bubbles, to the nature of the labour market and the determinants of unemployment, to transition in former communist countries, to the global financial crisis. He is the author of many books and articles. He is a past chair of the MIT economics department, a fellow and past council member of the Econometric Society, and a member of the American Academy of Sciences. He is currently the President elect of the American Economic Association.

He is the author of many books and articles, including *Macroeconomia* (with A. Amighini and F. Giavazzi), Il Mulino (2016), *Scoprire la macroeconomia*, (with A. Amighini and F. Giavazzi), Il Mulino (2016); *Social media ROI*, Hoepli (2012).

### **AXEL BÖRSCH-SUPAN**

In his role as director of the Max Planck Institute for Social Law and Social Policy in Munich, he has headed the Munich Center for the Economics of Aging (MEA) since 2011.

He is full Professor for the Economics of Aging at the Technical University of Munich (TUM).

He previously taught at Harvard University (1984-1987), and at the universities of Dortmund (1987-1989) and Mannheim (1989-2011).

He is a full member of the Berlin-Brandenburg Academy of Sciences and German National Academy of Sciences Leopoldina and a corresponding member of the Austrian Academy of Sciences. He also coordinates the Survey of Health, Ageing and Retirement in Europe (SHARE).

He is a member of the Council of Advisors to the German Economics Ministry (chair 2004-08), a member of the German federal governments' Expert Group on Demography and has served as a consultant to the European Commission, the World Bank, the OECD and several foreign governments.

He has published numerous articles and edited *The Individual and the Welfare State*, Springer (2011), with M. Brandt, K. Hank and M. Schröder.

### **ANDREA BRANDOLINI**

Joining the Research Department of the Banca d'Italia in 1992, from 2007 to 2012 he was head of the Economic Structure and Labour Market Division. Since June 2015 he has been head of the Statistical Analysis Directorate. He represented the Bank of Italy in government commissions investigating poverty and the ministerial working group on minimum income. He chaired the Istat research committee on methods for estimating absolute poverty. He has been a member of the World Bank Commission on Global Poverty and President of the International Association for Research in Income and Wealth (IARIW). He is one of the founders of the demographic information web site [www.neodemos.it](http://www.neodemos.it).

He has published numerous papers on poverty, the distribution of wealth and measuring wellbeing. Together with S.P. Jenkins, J. Micklewright and B. ### **AGAR BRUGIAVINI**

She is a Lecturer in Political Economy at Ca' Foscari University in Venice, Director of the Scuola Superiore "Collegio Internazionale Ca' Foscari" and Director of the CINTIA research centre. She is Chair of the Scientific Committee of the Max Planck Institute in Munich. Her research interests include consumer choices and family savings, pensions, labour participation and the economics of ageing. She plays a key role in the European SHARE project.

She has published numerous academic articles and has written for scientific magazines; she is on the editorial committee of the Journal of Pension Economics and Finance. Her publications include, *Longer-term Consequences of the Great Recession on the Lives of Europeans* (with G. Weber), Oxford University Press (2014); *Il muro delle pensioni. ### **MARKUS BRUNNERMEIER**

He is the Edwards S. Sanford Professor at Princeton University. He is a faculty member of the Department of Economics and director of Princeton's Bendheim Center for Finance. He is also a research associate at NBER, CEPR, and CESifo. He is/was a member of several advisory groups, including to the IMF, the Federal Reserve of New York, the European Systemic Risk Board, the Bundesbank and the U.S. Congressional Budget Office. He was awarded his Ph.D. by the London School of Economics (LSE).

His research focuses on international financial markets and the macroeconomy with special emphasis on bubbles, liquidity, financial and monetary price stability. He is a Sloan Research Fellow, Guggenheim Fellow, Fellow of the Econometric Society and the recipient of the Bernácer Prize granted for outstanding contributions in the fields of macroeconomics and finance. He is co-founder of the euro-nomics group which developed the European bond structure ESBies (SBBS). His recent book is titled *The Euro and the Battle of Ideas* (with H. James and J.-P. Landau).

### **FLAVIA BUSTREO**

Since 2010 she has been Assistant Director General for the Family, Women's and Children's Health at the World Health Organisation. For over 20 years she has concerned herself with the field of maternal and child health within the WHO. In 2010 she led the development of the United Nations Global Strategy for Women's and Children's Health and she has contributed to creating the Partnership for Maternal, Newborn and Child Health. She has worked as a specialist doctor with disabled children and adolescents and with NGOs involved in post-conflict operations in the former Yugoslavia and in Iraq.

Cinzia Caporale heads the Rome branch of the Istituto di Tecnologie Biomediche and coordinates the CNR's Committee for Research Ethics and Bioethics. A lecturer in bioethics at "La Sapienza" University in Rome, she is a member of the National Bioethics Committee (PM's office) and Chair of the Ethics Committee of IRCCS L. Spallanzani and that of the Fondazione Umberto Veronesi. She has been Chair of UNESCO's Intergovernmental Bioethics Committee for two terms. She is editor of the scientific magazine "The Future of Science and Ethics". She writes for "Il Sole 24 Ore".

### **HARRY CARSON**

He played 13-years with the New York Football Giants of the National Football League. He served as Team Captain 10 of his 13 seasons including the 1986 season when the Giants defeated the Denver Broncos 39-20 in Super Bowl XXI. He is among the top 250 players to ever play professional football with his 2006 induction as the 231st member of the Pro Football Hall of Fame.

During his extensive football career including high school, college and professionally he sustained numerous injuries including concussions. After his career ended in 1988 he was diagnosed with post concussion syndrome in 1990. Shortly after his diagnosis he began to speak openly on sports related traumatic brain injuries in athletes. ### **LAWRENCE R. COIA**

He is a physician who has lectured in the United States on the health aspects of wine. He is currently studying the impact of wine and all aspects of its production on the health and well-being of society.

### **SERGIO FABBRINI**

He is Director of the LUISS School of Government and Professor of Political Science and International Relations at LUISS Guido Carli. He co-founded the International Studies School at the University of Trento and was its Director from 2006 to 2009. He is Recurrent Professor of Comparative Politics at the Department of Political Science and the Institute of Governmental Studies of the University of California in Berkeley. In 2006 he was the first Italian scholar to be awarded the Amalfi European Prize for the Social Sciences. ### **SILVIO GARATTINI**

A doctor and freelance lecturer in chemotherapy and pharmacology, he was first an assistant and then lecturer at the University of Milan's Institute of Pharmacology until 1962. In 1963 he founded the Istituto di Ricerche Farmacologiche "Mario Negri" and since then he has been its Director. ### **HAROLD JAMES**

Claude and Lore Kelly Professor in European Studies, he is Professor of History and International Affairs and the Director of the Program in Contemporary European Politics and Society at Princeton University. He studies economic and financial history and modern European history.

He was a Fellow of Peterhouse for eight years before joining Princeton University in 1986. In 2004 he was awarded the Helmut Schmidt Prize for Economic History, and in 2005 the Ludwig Erhard Prize for writing about economics.

From 1977 through 1983, he served on the faculties of economics of the University of California, Los Angeles, and Yale University. ### **MICHAEL KREMER**

He is the Gates Professor of Developing Societies in the Department of Economics at Harvard University. He is a Fellow of the American Academy of Arts and Sciences, a recipient of a MacArthur Fellowship and a Presidential Faculty Fellowship, and was named a Young Global Leader by the World Economic Forum.

His recent research examines education, health, water, and agriculture in developing countries.

He has been named as one of Scientific American's 50 researchers of the year, and has won awards for his work on health economics, agricultural economics, and on Latin America. He helped develop the advance market commitment (AMC) for vaccines to stimulate private investment in vaccine research and the distribution of vaccines for diseases in the developing world. He is the founding Scientific Director of Development Innovation Ventures (DIV) at USAID.

He has published numerous articles and books, including *Strong Medicine: Crating Incentives for Pharmaceutical Research on Neglected Diseases* (with R. Glennerster), Princeton University Press (2016); *Small Changes, Big Results: Behavioral Economics at Work in poor Countries*, Boston Review (2011).

### **ALAN B. KRUEGER**

Bendheim Professor of Economics and Public Affairs at Princeton University, he has held a joint appointment in the Economics Department and Woodrow Wilson School since 1987. He is the founding Director of the Princeton University Survey Research Center.

He served as Chairman of President Barack Obama's Council of Economic Advisers and a Member of his Cabinet in 2011-13. He also served as Assistant Secretary for Economic Policy and Chief Economist of the U.S. Department of the Treasury in 2009-10, and as Chief Economist at the U.S. Department of Labor in 1994-95.

He has published widely on the economics of education, terrorism, unemployment, labor demand, income distribution, social insurance, labor market regulation and environmental economics.

He is the author of *What Makes A Terrorist: Economics and the Roots of Terrorism*, Princeton University Press (2007); *Inequality in America: What Role for Human Capital Policies* (with J. Heckman), Cambridge, MA: MIT Press (2004) and *Myth and Measurement: The New Economics of the Minimum Wage* (with D. Card), Princeton University Press, 1995. He is currently writing a book on Rockonomics, on the economics of the music industry (forthcoming Penguin Press).

### **NICOLA LACETERA**

He is Associate Professor of Economics and Management at the University of Toronto, Canada, and a member of the National Bureau of Economic Research in the USA. He previously lectured at the Case Western Reserve University (Cleveland, USA). Graduating from Bocconi University, he obtained a research doctorate from Massachusetts Institute of Technology. His research interests concern experimental economics, the role of ethics and psychology in economic decisions, and the economics of innovation and industrial organisation. ### **WILLIAM LAZONICK**

He is a professor of economics at the University of Massachusetts Lowell. He is co-founder and president of The Academic-Industry Research Network. Previously, he been a faculty member at Harvard University, Barnard College of Columbia University, and INSEAD in France. ### **MARIO MACIS**

He is Associate Professor of Economics at Johns Hopkins University, where he lectures in microeconomics and the economics of human resources, and is the Academic Programme Director for the master's degree in Health Care Management. After obtaining a degree in Economic and Social Disciplines from Bocconi University, he received a PhD in Economics from the University of Chicago. His research focuses on the interaction between ethics and economics, global health, experimental economics, labour economics and development economics.

He has been a consultant for the World Bank, the International Labour Organization and the United Nations Development Programme.

### **IGNAZIO MARINO**

He is Professor of Surgery at the Sidney Kimmel Medical College, and Distinguished Adjunct Professor of Science at Temple University, USA. He is currently Strategic Advisor to the President and CEO at the Thomas Jefferson University of Philadelphia. He was previously Professor of Surgery at the University of Pittsburgh. In 1992-1993, he was a member of the team carrying out the first liver transplant from a baboon to a human being in the history of medicine. Between 2006 and 2013, he was a Senator of the Italian Republic and from June 2013 to October 2015 he was Mayor of Rome. ### **MICHAEL MARMOT**

He is Professor of Epidemiology at University College London, and President of the World Medical Association. He is the author of *The Health Gap: the challenge of an unequal world*, Bloomsbury, 2015, and *Status Syndrome: how your place on the social gradient directly affects your health*, Bloomsbury, 2004. He holds the Harvard Lown Professorship for 2014-2017 and is the recipient of the Prince Mahidol Award for Public Health 2015.

He chairs the Commission on Equity and Health Inequalities in the Americas and he is a Member of the National Academy of Medicine.

As Chair of the Commission on Social Determinants of Health (CSDH) he produced the report entitled *Closing the Gap in a Generation* in August 2008.

At the request of the British Government, he conducted the Strategic Review of Health Inequalities in England post 2010, which published its report *Fair Society, Healthy Lives* in 2010. This was followed by the *European Review of Social Determinants of Health and the Health Divide*, for WHO Euro in 2014.

He is the author of *The Health Gap: The Challenge of an Unequal World*, Bloomsbury (2015), and *Status Syndrome: How your Place on the Social Gradient Directly Affects your Health*, Bloomsbury (2004).

### **SHANNON MONNAT**

She is Assistant Professor of Rural Sociology, Demography, and Sociology and a Research Associate in the Population Research Institute at the Pennsylvania State University. Her areas of expertise include rural demography, health and health disparities, spatial differences in drug, alcohol and suicide Mortality, and stratification and inequality. Broadly, her research interests lay at the intersection of demography, sociology, and public health. Her current efforts largely focus on social, behavioral, and spatial variation in and determinants of health and health disparities among adolescents, young adults, and families along the U.S. rural-urban continuum.

She has published numerous articles, in addition to the book *Reading Women's Lives*, Pearson (2008).

### **JEAN PISANI-FERRY**

He is Senior Professor of Economics and Public Management at the Hertie School of Governance, and has served as Commissioner-General for Policy Planning since 2013, reporting to the French Prime Minister.

He helped found the Brussels-based economic think tank Bruegel in 2005 and served as its director. He has taught at Université Paris-Dauphine, Ecole Polytechnique and the Université libre de Bruxelles.

He has been a correspondent in Peking, San Francisco, Paris and Brussels, and Deputy Editor of the "Sole 24 Ore" newspaper. He has lectured at the Universities of Berkeley, Shanghai and SDA-Bocconi. He created and interpreted two theatre performances, *Occidente estremo, vi racconto il nostro futuro* and *All You Need Is Love*.

### **GIUSEPPE REMUZZI**

He has been Director of the Nephrology and Dialysis Unit since 1999, and Director of the Department of Medicine at ASST Papa Giovanni XXIII (formerly the Riuniti Hospital) in Bergamo since 2011. Since 2015 he has been Ordinary Professor of Nephrology at the University of Milan. He coordinates all the research activities at the Bergamo branch of the Istituto Mario Negri and the Centro di Ricerche Cliniche per le Malattie Rare "Aldo e Cele Daccò" in Ranica (BG). He has received numerous prestigious awards for his scientific and research activities in the field of nephrology.

### **WALTER RICCIARDI**

Ordinary Professor of Hygiene and Director of the Specialist School of Hygiene and Preventive Medicine at the "A. Gemelli" Faculty of Medicine and Surgery at the Università Cattolica del Sacro Cuore in Rome, in August 2015 he was nominated President of the Istituto Italiano Superiore di Sanità, where he was Commissioner from July 2014 to July 2015. He is a Past President of EUPHA. In Italy he was a member of the National Health Council in the period 2003-2006, and was nominated President of the Public Health Section of the Council by the Minister of Health from 2010 to 2014. ### **CARLA ROSSI**



Graduating in Mathematics with Bruno de Finetti in 1971, since 1981 she has been Ordinary Professor of Mathematical Statistics and then Medical Statistics at "Tor Vergata" University in Rome. Her research concerns various sectors: mathematical models and statistical methodologies, applications in the biomedical and social field, and new indicators for assessing policy and applications. Thanks to collaboration with institutions and international organisations, her scientific activities have resulted in over 150 articles in international scientific magazines, and 40 scientific, educational and popular books. From 2000 to 2015 she was a representative of the European Parliament on the Management Board of the European Monitoring Centre for Drugs and Drug Addiction. ### **ALVIN E. ROTH**

He shared with Lloyd S. Shapley the 2012 Nobel Memorial Prize in Economics "for the theory of stable allocations and the practice of market design".

He is the Craig and Susan McCaw Professor of Economics at Stanford University and the Gund Professor of Economics and Business Administration Emeritus at Harvard.

He works in the areas of game theory, experimental economics and market design. His research focuses on organization of labor (and other) markets, bargaining, and learning in strategic environments.

His work has been published in top economic journals including "American Economic Review", "Quarterly Journal of Economics", "Journal of Economic Perspectives", "American Economic Review", "American Journal of Transplantation", "Journal of Behavioral Decision Making".

He is the author of *Como Funcionam os Mercados*, Portfolio-Penguin (2016); *Who Gets What—and Why: The New Economics of Matchmaking and Market Design*, An Eamon Dolan Book, Houghton Mifflin Harcourt (2015); *Who Gets What and Why*, Eamon Dolan/Houghton Mifflin Harcourt (2015).

### **CHIARA SARACENO**

A sociologist graduating in philosophy, she is an honorary fellow of the Collegio Carlo Alberto in Turin. Until 2008 she lectured at the University of Turin; she was Director of the Department of Social Science (1991-1998) and the Interdepartmental Centre for Studies and Research on Women (1999-2001), and a member of the Italian investigative committee on poverty and marginalisation (2000-2001). Until 2011 she was Research Professor at the Wissenschaftszentrum für Sozialforschung in Berlin, where she is currently Professor Emeritus.

Her studies concern in particular: family policy and changes; strategies for reconciling home and work commitments; relationships between genders and generations; welfare systems. Her most recent books include: *L'equivoco della famiglia*, Laterza (2017); *Mamme e papà. Gli esami non finiscono mai*, Il Mulino (2016); *Coppie e famiglie. Non è questione di natura*, Feltrinelli (2016); *Il lavoro non basta. La povertà in Europa negli anni della crisi*, Feltrinelli (2015).

### **NEMAT SHAFIK**

She is the new Director of the London School of Economics and Political Science (LSE), effective from 1 September 2017.

Previously (August 2014-February 2017) she served as Deputy Governor of the Bank of England where she was a member of the Monetary Policy Committee, the Financial Policy Committee, and the Board of the Prudential Regulation Authority.

From 2011 to 2014 she was Deputy Managing Director of the International Monetary Fund, Permanent Secretary of the Department for International Development, and Vice-President of the World Bank.

From March 2008 to March 2011 she was Permanent Secretary of the Department for International Development (DFID). Prior to joining DFID in 2004, she was the youngest ever Vice President at the World Bank.

She was named a Dame Commander of the British Empire by the Queen in 2015 and has appeared on Forbes' list of the world's 100 most powerful women.

She has published on a wide array of topics in economics and international development.

Among other things, she has written, *Challenges Facing Middle Eastern and North African Countries*, Palgrave Macmillan (1997) and *Prospects for Middle Eastern and North African Economies*, Plagrave Macmillan (1997).

### **ALESSANDRO SOLIPACA**

Since 1998 he has been a Senior Researcher at the Istituto Nazionale di Statistica, where since 2002 he has been in charge of the computer system on disabilities. Since 2012 he has been the scientific coordinator of the national monitoring unit on health in Italian regions at the Università Cattolica del Sacro Cuore in Rome. He carries out research in the health sector regarding public expenditure, analysis of supply and demand in the health sector, behavioural consumer models and decisive socioeconomic factors in health. He also deals with issues linked to the social inclusion of people with disabilities and he is the author of numerous articles in Italian and international scientific magazines.

### **GINO STRADA**

He is a doctor specialising in emergency surgery. Until 1988 he worked at the hospitals of Rho (Milano) and Bergamo, where he dealt mainly with heart transplant surgery. From 1989 to 1994, he worked in war zones for the International Committee of the Red Cross: Pakistan, Ethiopia, Thailand, Afghanistan, Peru, Djibouti, Somalia and Bosnia-Herzegovina.

In 1994, together with his wife, he founded Emergency, an association offering free high quality medical and surgical treatment to the victims of war and poverty, continuing to dedicate his time to humanitarian activities. As a result of his great humanity, the precious work carried out in war zones and his continuing denunciation of the causes of war, in 2015 he was the first Italian to be awarded the Right Livelihood Award, known as the alternative Nobel Prize.

He has written: *Zona rossa* (with R. Satolli), Feltrinelli (2015); *Buskashì. Viaggio dentro la guerra*, Feltrinelli (2013); *Pappagalli verdi. Cronache di un chirurgo di guerra*, Feltrinelli (2013).

### **KIERSTEN STROMBOTNE**

She is a Health Economist at the American Institutes for Research (AIR) in Washington, D.C. In recent years, her research has investigated the social, behavioral, and policy drivers of child obesity in school settings; this work reflects her broader interest in understanding how social influences can be used to design more effective policies to alleviate health disparities across the life course. She holds a PhD in Health Policy and Management from Yale University.

### **JEAN TIROLE**

A recipient of many honors and prizes, he was awarded in 2014 the Nobel Memorial Prize in Economics "for his analysis of market power and regulation".

He is chairman of the Foundation JJ Laffont-Toulouse School of Economics. He is also affiliated with MIT, where he holds a visiting position, and with the pluridisciplinary Institute for Advanced Study in Toulouse, which he helped found in 2011. He has published widely in the areas of industrial organization, regulation, organization theory, game theory, finance, macroeconomics and psychology, including: *The Theory of Corporate Finance*, Princeton University Press (2006), *Game Theory* (with D. Fudenberg), The MIT Press (1991).

### **GILBERTO TURATI**

He is Associate Professor of Financial Science at the Università Cattolica del Sacro Cuore (Rome branch). He is part of the editorial team of "lavoce.info", the editorial committee of "Politica Economica - Journal of Economic Policy" and the independent assessment organisation of the Azienda Ospedaliera Ordine Mauriziano in Turin. He is an external affiliate of the Health, Econometrics and Data Group of the Centre for Health Economics at the University of York. For several years, he was responsible for the Master's degree in Economics and Health Policy for CORIPE Piemonte and at the University of Turin.

Among other things, he has published "Così fan tutti. Sull'evasione fiscale in Italia", in "Vita e Pensiero" in 2010; *Decentramento fiscale, riorganizzazione interna e integrazione socio-sanitaria* (with P. Bosei and N. Dirindin), Vita e Pensiero (2009); *Sistemi sanitari regionali in Italia* (with M.S. Caroppo), Vita e Pensiero (2007).

### **GIOVANNI VECCHI**

He is Professor of Economics at the University of Rome "Tor Vergata", where he teaches economic history, statistical computing, and welfare analysis. His interests span the theory, measurement, and history of welfare, and Italy's long-run economic history. He is a World Bank consultant on poverty and inequality and has also advised governments and statistical agencies on these issues. He has written extensively on Italian economic history including *Measuring Wellbeing. A History of Italian Living Standards*, Oxford University Press, (2017) and *In ricchezza and povertà. Il benessere degli italiani dall'unità a oggi*, Il Mulino (2011).

He is the founding president of the Italian Economic History Association and co-editor of the "Rivista di storia economica".

### **STEFANO VELLA**

Since 1 January 2017 he has been Director of the Centro Nazionale per la Salute Globale at the Istituto Superiore di Sanità. From 2003 to 2016 he headed the Pharmacy Department of the ISS, combining pharmaceutical control and research activities in various fields of human pathology at both national and international level. He currently participates in three major European research projects (two on innovation in health systems and one on HIV treatment), as well as continuing programmes of operational research in Africa and other countries with limited financial resources, in collaboration with the health authorities of various countries and with the Agenzia Italiana per la Cooperazione allo Sviluppo. In 2000 he organised a major international conference on AIDS in Durban, South Africa, representing the turning point in the battle for universal access to AIDS treatment and the establishment of the Global Fund to fight Tuberculosis, AIDS and Malaria (GFTAM).

He is the author or co-author of over 300 scientific papers in international magazines. He edited the book *Hiv/Aids: storia, cura, prevenzione. Una epidemia globale tra passato e futuro*, Franco Angeli (2016), and he has published *Farmacologia di genere* (with F. Franconi and S. Montilla), Società Italiana di Farmacologia (2010); *No Aids. Globalizzare il diritto alla salute* (with D. Minerva), Avverbi (2002).

### **PAOLO VINEIS**



He is Chair of Environmental Epidemiology at Imperial College, London, and Head of the Unit of Genetic and Molecular Epidemiology at the HuGeF Foundation, Torino, Italy. He is a leading researcher in the fields of molecular epidemiology and exposomics. His latest research activities mainly focus on examining biomarkers of disease risk, as well as studying the effects of climate change and inequalities on non-communicable diseases.

He is a member of various international scientific and ethics committees and vice-chair of the Ethics Committee at the International Agency for Research on Cancer (IARC, WHO).

He has more than 800 publications (many as leading author) in journals such as "Nature", "Nature Genetics", "Lancet", "Lancet Oncology". He has also published several books, including: *Salute senza confini. Le epidemie della globalizzazione*, Codice (2014); *I due dogmi. Oggettività della scienza e integralismo etico* (with R. Satolli), Feltrinelli (2009); *Elementi di economia sanitaria* (with N. Dirindin), Il Mulino (2004).

### **GIANLUCA VIOLANTE**

He is a Professor of Economics at Princeton University.

Before joining Princeton in 2017, he taught at University College London and New York University. He holds a Ph.D. in Economics from the University of Pennsylvania.

His main research interests are in macroeconomics and labor economics. Among other journals, he has published his research in the "American Economic Review", "Econometrica", "Journal of Political Economy", "Quarterly Journal of Economics", and "Review of Economic Studies".

He is a Research Associate of the NBER, a Research Fellow of the CEPR and IZA, and an International Fellow of the IFS.

He is currently one of the Co-Editors of "Econometrica".

### **GUGLIELMO WEBER**

Holding a PhD from the London School of Economics, he is Professor of Econometrics and Director of the Department of Economic and Business Science at the University of Padua. He is also the Italian coordinator and European deputy coordinator of the SHARE investigation ("Over-50s in Europe").

His research interests concern consumer choices and family saving, the economics of education, and the economics of ageing, in particular the effects of retirement on cognitive ability, physical and mental health. He has published *Cose da non credere. Il senso comune alla prova dei numeri* (with G. Dalla Zuanna), Laterza (2011).

### **LUIGI ZINGALES**

He is Professor of Finance at the University of Chicago Booth School of Business, and Director of the Stigler Center. He holds a PhD in Economics from MIT. Among the most cited economists in the world, in 2012 he was included in the list of the 100 most influential thinkers in the world by the magazine "Foreign Policy". In 2003 he was awarded the Bernacer Prize for the best young European financial economist. In 2014 he was President of the American Finance Association.
